4. New Code Enforcement Officer - *Alderman Ashe made a motion that the Board approve the hiring of Larry Berrier to be the Village's Code Enforcement officer. Motion was seconded by Alderman Fields, motion carried unanimously.*
5. Approval of CEFCO Convenience Store Building Permit - *Alderman Brown made a motion that the Board approve the building permit for Fikes Construction to build a CEFCO Convenience Store as submitted. Motion was seconded by Mayor ProTem Fritch, motion carried unanimously.*
