Minutes of Special Meeting of Board of Aldermen  
May 16, 2022 at 6:00 p.m.**

The Board of Aldermen meeting was called to order at 6:00 p.m. by Mayor Pro-tem Rodney Bell.

Board Members Present: Mayor Pro-tem Rodney Bell and Aldermen John Cole and D. Jasen Graham. Mayor Michael Coggin, Alderman Paul Cox, and Alderman Jason Howard were absent. Mayor Pro-tem Bell assumed duties as presiding officer.

**Election Matters**

- A. Canvass returns of the Village of Salado General Election of May 7, 2022. (*Village Administrator*)

Village Administrator Ferguson explained quorum requirements for the purpose of canvassing election results and reviewed canvass materials distributed to Board members. He presented the following results to the Board:

- B. Discuss and consider approval of an ordinance of the Village of Salado, Texas, declaring the canvass of the results of the May 7, 2022, General Election held for the purpose of electing a mayor and two (2) aldermen of the Village of Salado Board of Aldermen and all matters related to holding such election; providing for findings of fact, providing for severability; repealing conflicting provisions; proper notice and open meeting, and providing an effective date. (*Village Administrator*)

Village Administrator Ferguson recommended approval of the ordinance declaring canvass results. Alderman Graham moved to approve the ordinance declaring the canvass of the results of the May 7, 2022 General Election, as presented. Alderman Cole seconded. Motion carried on a vote of 3-0.

- C. Complete and issue Certificates of Election to the mayor-elect and aldermen-elect. (*Mayor Michael Coggin*)

Mayor Pro-tem Bell signed the Certificates of Election to be presented to Mayor-elect Michael Coggin and Aldermen-elect Jason Howard and Paul Cox.
