Minutes of Special Called Meeting/Public Hearing of Board of Aldermen August 26, 2024, at 6:30 p.m.

Motion made by Alderman Graham, seconded by Alderman Hurst to approve Ordinance No. 2024-14, an ordinance of the Village of Salado, Texas, setting a property (ad valorem) tax rate; approving the ad valorem tax rate and levy of \$0.4860 per one hundred dollars (\$100) of assessed valuation of all maxable property within the corporate limits of the village for the 2024 tax year to fund the fiscal year 2024-2025 operating budget for the Village of Salado; providing for an exemption on residence homesteads; providing for exemptions for individuals who are disabled or 65 years of age or older; providing for penalties and interest; providing for severability; providing for repealing conflict; providing for proper notice and meeting; providing for engrossment and enrollment; providing for notification to assessor; and providing for publication and effective date. All approved and motion carried by a vote of four in favor, none opposed.
