

ORDINANCE NO. 2021-02

**AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS, CANCELLING THE MAY 1, 2021 GENERAL ELECTION AND DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE; ESTABLISHING POSTING REQUIREMENTS FOR THE ORDER OF CANCELLATION; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, a General Election was ordered by the Board of Aldermen of the Village of Salado, Texas located in Bell County to be held on May 1, 2021, for the purpose of electing three (3) Aldermen; and

**WHEREAS**, pursuant to Section 2.052 of the Texas Election Code, the deadline for filing applications for a place on the ballot and the deadline for filing as a write-in candidate has expired; and

**WHEREAS**, the City Secretary has presented a Certification of Unopposed Candidates, attached hereto as Exhibit A, for the May 1, 2021, General Municipal Election to the members of the Board of Aldermen.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS, THAT:**

**SECTION 1.**

The Board of Aldermen of the Village of Salado hereby cancels the election scheduled to be held on May 1, 2021, in accordance with Section 2.053(a) of the Texas Election Code. The following candidates have been certified as unopposed and are hereby declared elected to the respective offices shown and shall be issued a certificate of election following the date on which the regular municipal election was to have been held:

- Rodney W. Bell           Alderman
- John F. Cole            Alderman
- D. Jasen Graham       Alderman

**SECTION 2.**

The Mayor is hereby authorized to sign an Order of Cancellation to be in a form substantially similar to Exhibit B, attached hereto and incorporated herein for all purposes.

**SECTION 3.**


The City Secretary, in conjunction with the Bell County Elections Administrator, is hereby directed to post a copy of the Order of Cancellation, on Election Day at each polling place that would have been used in said election.

**SECTION 4.**

This ordinance shall become effective from and after its passage and approval.
