ADDENDUM NO. 1

The construction plans, specifications and contract documents for the South Ridge Sawtooth Curb Repair Project in Salado, Texas on which bids are scheduled to be received until 10:00 a.m. on Friday, January 28, 2022, are hereby modified:

I. GENERAL

- A. A Non-mandatory Pre-Bid Conference/Meeting was scheduled to be held at Village of Salado Municipal Building beginning at 10:00 AM on Tuesday, January 11, 2022. There were no attendees, so the meeting was cancelled.
- B. The right is reserved, as the interest of the Village of Salado may require, to reject any and all bids and to waive minor technicalities in bids received. The right is also reserved to eliminate a portion of the work, add additional work, or award any part or combination of parts or add alternates as required to keep the total contract amount within the funds budgeted.
- C. Contractor shall follow all Village of Salado ordinances.
- D. The Contractor shall be responsible for providing shop drawings / submittals / product samples as outlined in the respective Technical Specifications. Any costs associated with any sampling and testing for submittals shall be the responsibility of the Contractor. These costs shall be considered as incidental and the Contractor will not be entitled to any additional compensation.
- E. Construction staking will not be provided for this project. The Contractor shall repair/construct sawtooth curb within the footprint of the existing curb alignment.
- F. Testing and control of construction materials and methods used in the Work shall be done by an approved local commercial laboratory employed and paid directly by the Village of Salado. Any retesting required as a result of a failed test result shall be paid for by the Contractor. Unless otherwise directed by the Engineer, testing frequency shall be the following: 4 cylinders per day of concrete placement.
- G. The Opinion of Probable Construction Cost for this project (Base Bid) is \$15,000.

II. BID FORM

- A. A Bid Schedule (PDF and Microsoft Excel) is attached to this Addendum. Bids shall be submitted on the Bid Schedule provided by the Engineer.
- B. Refer to Bid Item 2. The description of this item is revised to read "For Furnishing and Implementing Traffic Control Plan, Complete For".

III. TECHNICAL SPECIFICATIONS

A. The TxDOT Standard Specifications for Construction and Maintenance of Highways, Streets, and Bridges, latest edition shall be used for all items for which technical specifications are not included either in the construction plans, specifications manual or in this addendum.

Bidders shall acknowledge receipt of this ADDENDUM NO. 1 in the space provided on the Bid Form and on the outer envelope of each sealed bid.
