I. BID FORM

- A. A revised Bid Schedule (PDF and Microsoft Excel) is attached to this Addendum. Bids shall be submitted on the revised Bid Schedule provided by the Engineer.
- B. Refer to Item 8 of the Bid Schedule. The quantity has been revised to 1,000 CY. This quantity includes roadway excavation and excavation for ribbon curb installation.
- C. Refer to Item A-1 of Add Alternate A. The quantity has been revised to -2,900 SY.
- D. Refer to Item A-2 of Add Alternate A. The quantity has been revised to 2,900 SY.
- E. Refer to Item B-1 of Add Alternate B. The quantity has been revised to -2,900 SY.
- F. Refer to Item B-2 of Add Alternate B. The quantity has been revised to 2,900 SY. Please note that this item is for cement treating the crushed limestone base material (CLBM) provided in Base Bid Item 10. Cement treatment will only be for CLBM placed between the curbs (i.e. CLBM under and behind the new curbs will not be treated.)

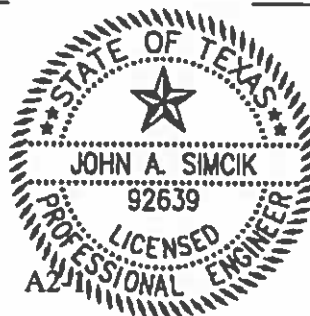
