WASTE DISPOSAL

AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, BELL COUNTY, TEXAS AMENDING ORDINANCE 2006.06, GRANTING TO REFUSE COLLECTORS, THEIR SUCCESSORS AND ASSIGNS, THE RIGHT TO ESTABLISH, OPERATE AND MAINTAIN TRASH AND REFUSE COLLECTION ROUTES WITHIN THE VILLAGE OF SALADO; AND PROVIDING INSURANCE REQUIREMENTS AND PERMIT FEES.

WHEREAS, several private refuse contractors are presently collecting and charging citizens and businesses for collection and disposal of refuse; and

WHEREAS, these collectors are utilizing Village streets in their daily operation and are not contributing to street maintenance and repair; and

WHEREAS, in the form of Ordinance 2006.06, the Village granted to three (3) private refuse collectors the nonexclusive right and privilege to collect, transport and to contract for refuse collection within the Village; and

WHEREAS, the Board of Aldermen now finds it to be reasonable, necessary, and in the public interest to extend the nonexclusive right and privilege to collect, transport and to contract for refuse collection within the Village to an additional private refuse collector.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS

SECTION I:

Section 3 of Ordinance 2006.06, is hereby amended so to read as follows:

There is hereby granted by the Village of Salado Texas (hereinafter called Village), to the following private refuse collectors:

- (a) Al Clawson Disposal, Inc.
- (b) Eagle Disposal
- (c) Centex Waste Management

(d) Temple Iron and Metal

(hereinafter called permittees), and their successors and assigns, for a term to expire April 1, 2009, the full term of three (3) years from the effective date of this Ordinance the right and privilege to collect, transport and to contract for refuse collection within the Village of Salado, Texas.

The Village hereby grants to Permittees the right to use the surface of any street, alley, or highway for the purpose of collecting refuse from the premises of citizens and businesses of Salado, Texas.

Section 2. Severability

If any provision, section, subsection, sentence, clause or phrase of this Ordinance, or the application of same to any person or set circumstances for any reason is held to be unconstitutional, void or invalid or for any reason unenforceable, the validity of the remaining portions of this ordinance of the application thereby shall remain in effect, it being the intent of the Board of Aldermen of the Village of Salado, Texas in adopting this ordinance, that no portion thereof or provision contained herein shall become inoperative or fail by any reason of unconstitutionality or invalidity of any portion or provision.

Section 3. Repealing Conflict

All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed to the extent of conflict with this Ordinance.

Section 4. Effective Date

This Ordinance shall become effective immediately upon adoption.
