ZONING FEES

AN ORDINANCE OF THE VILLAGE OF SALADO ESTABLISHING MUNICIPAL FEES FOR ZONING APPLICATIONS, PROVIDING FOR A SEVERABILITY CLAUSE, AN EFFECTIVE DATE, PROPER NOTICE AND OPEN MEETING.

WHEREAS, certain fees charge by the Village of Salado for municipal services are inadequate due to the increase in administrative costs and other inflationary pressures; and

WHEREAS, such fees are designed to defray the cost of proper administrative review of each service; and

WHEREAS, the Board of Aldermen has determined to increase or add such fees to defer the costs of such municipal services;

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE OF SALADO BOARD OF ALDERMEN:

SECTION I.

That the following fee schedule is established (all fees are non-refundable):

Zoning Application: \$200.00 plus \$3.00/acre – residential districts

\$300.00 plus \$5.00/acre - non-residential districts

\$400.00 plus \$6.00/acre - PD development

\$100.00 plus \$6.00/acre Zoning Appeal:

\$150.00 plus \$1.00/acre Land Study:

Site Plan: \$No charge when submitted with a zoning request

Otherwise, \$150.00 plus \$6.00/acre

Preliminary Plat: \$125.00 plus \$4.00/lot

Single Lot: \$125.00

\$150.00 plus \$7.00/acre for non-residential districts Final Plat:

\$150.00 plus \$30.00/acre with ED Zoning District

\$150.00 plus \$5.00/lot all other districts

Replat: \$125.00 plus \$5.00/lot

Variance Request: \$75.00

SECTION III. EFFECTIVE DATE

The fees established by this ordinance shall take effect immediately from and after its passage, and it is accordingly so resolved.

SECTION IV. PROPER NOTICE AND MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required and that public notice of the time, place and purpose of said meeting was given as required by the Texas Open Meetings Act, Chapter 551 of the Texas Government Code. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.


