Ordinance No. 2002.11 Village of Salado **County of Bell State of Texas** July 3, 2002

AN ORDINANCE ESTABLISHING CERTAIN TRAFFIC SIGN LOCATIONS IN THE VILLAGE OF SALADO; PROVIDING FOR APPLICABILITY AND AN **EFFECTIVE DATE** AND PROVIDING FOR A SEVERABILITY CLAUSE.

WHEREAS, it is deemed to be in the best interest of the VILLAGE OF SALADO, to establish the location for the installation of certain traffic signs in order to better facilitate the flow of traffic throughout the village:

NOW THEREFORE, be it ordained by the Board of Aldermen of the Village of Salado:

- 1. That traffic signs shall be implemented, changed, or intstalled in accordance with the locations set forth on Exhibit "A", attached hereto.
- 2. In the event that any one or more of the provisions, clauses, or words of this ordinance or the application thereof to any situation or circumstance shall for any reason be held to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect any other provisions, clauses, or words of this ordinance or the application thereof to any other situations or circumstance and it is intended that this ordinance shall be severable and that it shall be construed and applied as if such invalid or unconstitutional clause, section, provision, or word had not been included herein.
- 3. This ordinance shall be effective upon its approval by the Board of Aldermen.
