

# VILLAGE OF SALADO RESOLUTION No. 079

# A RESOLUTION OF THE BOARD OF ALDERMEN DESIGNATING AN OFFICIAL NEWSPAPER AND AN ALTERNATE OFFICIAL NEWSPAPER FOR THE VILLAGE OF SALADO FOR FISCAL YEAR 2011 - 2012

- WHEREAS, the Board of Aldermen finds that the Salado Village Voice newspaper and the Temple Daily Telegram newspaper are both a paper of general circulation within the Village of Salado; and
- **WHEREAS,** the Board of Aldermen finds that the Salado Village Voice and the Temple Daily Telegram:
  - (1) devotes not less than 25% of its total column lineage to general interest items;
  - (2) is published at least once each week;
  - (3) is entered as  $2^{nd}$  class postal matter in the county where published; and
  - (4) has been published regularly and continuously for at least 12 months before the governmental entity or representative publishes notice; and
- **WHEREAS,** the Board of Aldermen finds that the Salado Village Voice and the Temple Daily Telegram are a publication that meets all of the criteria legally required of an officially designated newspaper for the Village of Salado.

# NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO THAT:

- 1. The Salado Village Voice is designated as the official newspaper for the Village of Salado for the fiscal year of 2011 2012 and the Temple Daily Telegram is designated as the official alternate newspaper for the Village of Salado for the fiscal year of 2011 2012, commencing on October 1, 2011.
- 2. The Village of Salado shall pay all applicable fees for its publications in the Village Voice as agreed upon between the Village and the Salado Village Voice per the attached price list.
- 3. The Village of Salado shall pay all applicable fees for its publications in the Temple Daily Telegram as agreed upon between the Village and the Temple Daily Telegram.
- 4. Until September 30, 2012, the Village of Salado shall continue to publish in the Salado Village Voice each ordinance, notice or other matter required to be published by law.

5. Until September 30, 2012, the Village of Salado may publish in the Temple Daily Telegram notices and other matters required to be published by law and which do not require publication in the official newspaper.

#### **Insert Rates:**

1,500 preprinted Inserts in newspapers delivered to stands and in mail: \$150. Inserts weighing more than 1 ounce each will be charged a weight fee to-be-determined.

Folding size: Inserts should be no larger than 8-1/2"x11" to fit in the newspaper. Folding Charge: \$75 per thousand. if larger than 8-1/2"x11".

#### **Classified Ad Rates:**

\$7 for up to 20 words. 25¢ per word thereafter, payable in advance. All classifieds are posted to our website, as well as printed in the newspaper.

### **Credit Policy:**

New customers pay upfront for the first six months to establish credit. Check, cash, money order, VISA and Mastercard accepted. Late fees of two percent per month applied to entire balance for accounts over 60 days. Accounts over 90 days will be terminated and turned over for legal collection. Delinquent accounts that have exceeded 90 days will have to pay entire balance and pay for all future advertising upfront. Delinquent account cannot qualify for contract discounts.
