

.RESOLUTION NO. 2015-117

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS, CANVASSING RETURNS AND DECLARING RESULTS OF THE GENERAL ELECTION, HELD ON MAY 9, 2015, FOR THE PURPOSE OF ELECTING THREE ALDERMEN.

RECITALS:

1. On February 19, 2015 the Board of Aldermen ordered that a General Election be held on May 9, 2014 for the purpose of electing Board of Aldermen.
2. Notice of this election was duly published in the Salado Village Voice on April 16.
3. A copy of the notice was posted on the bulletin board at City Hall.
4. The election was duly and legally held on May 9, 2015, in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the proper judges and clerks.
5. The Board of Aldermen of the Village of Salado, Texas with the following members present: Mayor Skip Blancett, Mayor Pro Tem Fred Brown, Alderwoman Amber Dankert, Alderman Michael McDougal, Alderman Hans Fields, Alderman Frank Coachman, thus constituting a quorum, have today considered the returns of the General Election held on May 9, 2015.
6. It appears to the Board of Aldermen, and the Board of Aldermen finds, that the election was in all respects lawfully held.
7. It appears to the Board of Aldermen, and the Board of Aldermen finds, that the tabulation of the results of the election is correct.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS;

SECTION 1. The General Election of May 9, 2015 was duly called, notice of the election was given in accordance with law, and the election was held in accordance with law.

SECTION 2. The tabulation of votes cast in the General Election held on May 9, 2015, for the purposes stated in Recital 1 above, a copy of which is attached to and made a part of this resolution is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the Village of Salado as the official canvass of the election.

SECTION 3. The official canvass of the returns of the election reflects the following:

A. For the positions of Board of Aldermen:



SECTION 4. That Michael McDougal, Fred Brown, and David Williams were elected to serve as Board of Aldermen subject to their taking the oath of office.


SECTION 5. It is hereby officially found and determined that the meeting at which this Resolution is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act.
