## **RESOLUTION**

A RESOLUTION OF THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO TO EXTEND THE DUTIES OF THE MAYOR TO TEMPORARILY PERFORM THE DUTIES AND EXERCISE THE POWERS PRESCRIBED BY THE GOVERNING BODY OF THE MUNICIPALITY NORMALLY ASSIGNED TO THE VILLAGE ADMINISTRATOR. THIS RESOLUTION WILL REMAIN IN EFFECT UNTIL A PERMANENT HIRE IS MADE FOR THE POSITION OF VILLAGE ADMINISTRATOR.

WHEREAS, the Board of Aldermen is adhering to the Local Government Code Sec. 22.042. POWERS AND DUTIES OF MAYOR. (a) The mayor is the chief executive officer of the municipality. The mayor shall at all times actively ensure that the laws and ordinances of the municipality are properly carried out. The mayor shall perform the duties and exercise the powers prescribed by the governing body of the municipality.

WHEREAS, the Board of Aldermen hereby finds and determines that the Mayor can temporarily perform the duties and exercise the powers normally prescribed to a Village Administrator to conduct the daily personnel and management duties without the expressed consent of the Board of Aldermen for each occurrence.

WHEREAS, the Board of Aldermen instructs the Mayor to adhere to all policies and procedures currently in place at the Village of Salado municipal offices.

WHEREAS, the Board of Aldermen further find that it is in the best interest of the Village to exercise this right per Local Government Code Sec. 22042 to oversee daily operations performed by the Village municipal staff;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO THAT,

Section 1. The findings of fact and recitations contained in the above preamble of this resolution are hereby incorporated, herein, for all purposes.

Section 2. The Mayor will temporarily perform the duties and the exercise the powers normally prescribed by the Board of Aldermen to a Village Administrator. The Resolution will remain in effect until a permanent hire is made for position of Village Administrator.

Section 3. This Resolution shall take effect immediately from and after its passage.
