## **RESOLUTION NO. R-2022-03**

A RESOLUTION OF THE VILLAGE OF SALADO, TEXAS, ADOPTING THE FY2023 COMMUNITY PROJECT FUNDING PRIORITY LIST FOR POTENTIAL FUNDING APPLICATIONS UNDER THE FEDERAL COMMUNITY PROJECT AND/OR FEDERAL APPROPRIATION SUBCOMMITTEE PROGRAMS

WHEREAS, the Village of Salado recognizes that in current times, the financing of public capital projects is becoming increasingly challenging in Texas and nationally; and

WHEREAS, in times of scarce resources, it is necessary to continue to find financing mechanisms and maximize the use of existing resources; and

WHEREAS, the Village of Salado is continuously analyzing potential state, local, and federal opportunities in a rapidly changing economic environment; and

WHEREAS, the Village of Salado desires to take the necessary actions to achieve critical project development for the maximum benefit to the community; and

**WHEREAS**, the Village of Salado has identified a critical capital improvement project which could be eligible under a specific federal grant program; and

**WHEREAS**, the Village of Salado recognizes that community engagement and support is a crucial part of project planning for any government entity; and

WHEREAS, the Village of Salado recognizes that state, federal, and local notice of funding opportunities such as these have specific, and at times, short submission deadlines; and

WHEREAS, the Village of Salado Board of Aldermen (the "Board of Aldermen") desires to participate in these federal financing opportunities, hereby, directs staff to seek, prepare, and submit applications for these federal funding opportunities as they become available; and

WHEREAS, the Board of Aldermen recognizes that this project is of high priority for the Village of Salado and as such, the Board of Aldermen further recognizes that certain federal grant programs may require state or local matching funding which can be made available at the time of award; and

**WHEREAS**, the Board of Aldermen retains its authority to accept and approve funding awards or contracts related to any funding opportunity applications submitted by the Village of Salado.

## NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE VILLAGE OF SALADO, TEXAS, that:

- 1. The Board of Aldermen has identified the Village of Salado Wastewater Treatment Plant Expansion Program as a FY2023 Community Project Funding Priority Project, and
- 2. The Mayor or his/her designee is delegated signature authority and shall take all actions necessary to seek and apply for funding of these projects, and
- 3. The Board of Aldermen retains its authority to accept and approve funding awards or contracts related to any funding opportunity applications submitted by the Village, and

4. The Board of Aldermen retains its authority to approve a budget amendment if needed for any related matching funding as is required by the grant program.
