A RESOLUTION OF THE VILLAGE OF SALADO DESIGNATING PERSONS WITH SIGNING AUTHORITY ON VILLAGE BANK ACCOUNTS

- WHEREAS, the Village of Salado has a need for bank accounts in accordance with their investment policy; and
- WHEREAS, it is prudent to establish appropriate accounts to achieve the city's investment policy of safety and liquidity; and
- WHEREAS, the board of aldermen has previously approved the Mayor, Investment Officer, and one other alderman as authorized signers of checks in the Financial Policies of the village: and
- WHERAS, banks routinely require all authorized signature authorities to be approved by the governing board;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO:

<u>Section 1</u>: The following individuals shall have authority to endorse and make deposits, sign checks, withdraw funds, and otherwise operate any and all bank accounts on behalf of the City:


