**WHEREAS**, the board of aldermen has previously approved the Mayor, Investment Officer, and one other alderman as authorized signers of checks in the Financial Policies of the village; and

**WHEREAS**, banks routinely require all authorized signature authorities to be approved by the governing board;

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO:**

Section 1: The following individuals shall have authority to endorse and make deposits, sign checks, withdraw funds, and otherwise operate any and all bank accounts on behalf of the City:
