Ordinance No. 2001.04 Village of Salado County of Bell State of Texas March 22, 2001

### AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE VILLAGE OF SALADO, TEXAS ESTABLISHING A DATE FOR A MUNICIPAL ELECTION; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE AND PROVIDING FOR NOTICE

WHEREAS, the statutes of the State of Texas provide that aldermen, the mayor and city marshall when initially elected are to serve until the next regular municipal election; and

WHEREAS, such provision would require the Village of Salado to hold a municipal election at the next regular municipal election date, to wit, May 5, 2001 for the purpose of electing five (5) aldermen, a mayor and a city marshall; and

WHEREAS, the Board of Aldermen of the Village of Salado by resolution agreed that a municipal election for the purpose of electing five (5) aldermen, a mayor, and a city marshall be held on the next regularly scheduled municipal election date, to wit May 5, 2001; and

WHEREAS, the Village of Salado Board of Aldermen wishes to proceed with the ordering of an election for Saturday, May 5, 2001, the next uniform municipal election date, and appointing election officials required for the conduct of the election, and has deemed it advisable to call the election hereinafter ordered; and

WHEREAS, the meeting to adopt this Ordinance was open to the public, and public notice of the time, place, and purpose of the meeting was given, all as required by Chapter 551 of the Government Code, as amended:

# THERERFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF SALDO:

- 1. That an election be held by the Village of Salado between the hours of 7:00am and 7:00pm CDST on May 5, 2001 for the purpose of electing five (5) aldermen, a mayor, and a city marshall at the following designated polling place, to wit the Salado Civic Center, 511 North Main, Salado, Texas 76571, which lies within the boundaries of the Village.
- 2. The following election officers are hereby appointed to hold the election at said location:

Presiding Judge: Alternate Presiding Judge: Jean Westerberg James Pringle

Attached hereto as Exhibit "A" and hereby incorporated by reference, is a description of the boundaries of the Village of Salado.

- 3. That the Presiding Judge shall appoint not less than two or more than ten qualified election clerks to serve and assist in conducting said election as further directed by the Village, provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of the clerks.
- 4. Voting in the election shall be by the use of paper ballots which shall be printed in both English and Spanish and which shall conform to the requirements of the Texas Election Code. Oral bilingual assistance shall be available during the election and may be obtained by contacting the Presiding Election Judge or Alternate Election Judge.
- 5. That early voting by personal appearance will be conducted between the hours of 7:30am and 4:30pm CDST beginning on April 18, 2001 and ending on May 1, 2001on each day which is not a Saturday, a Sunday or an official state holiday. Early voting on Wednesday, April 25, 2001 will be conducted between the hours of 7:30am and 7:00pm CDST. Early voting by personal appearance will be conducted at the following location:

Salado Civic Center 511 North Main Salado, Texas 76571

The early voting clerk shall keep the early voting place open during such hours for early voting by personal appearance. The early voting clerk for the election shall be James Pringle and the deputy early voting clerk for said election shall be Jean Westerberg.

Applications for early voting ballots by mail must be received by the close of Business on April 26, 2001.

6. That an Early Voting Ballot Board is hereby created to process early voting results, and Jean Westerberg shall serve as presiding judge of the Early Voting

Ballot Board. The presiding judge shall appoint at least two other members of said board.

- 7. The election shall be held and conducted and returns made to the Village Board of Aldermen in accordance with the Texas Election Code.
- 8. The cost of the election shall be shared proportionately with the Salado Independent School District and the Board of Trustees of the Salado Public Library.
- 9. That all qualified resident electors of the Village of Salado shall be entitled to vote at said election.
- 10. The Secretary of the Village of Salado is hereby directed to cause notice of this election to be published once in both English and Spanish in a newspaper of general circulation published in Bell County, Texas and in the Village of Salado not more than 30 days before the date set for election. In addition, a substantial copy of this Ordinance shall be posted in three public places within the Village of Salado and Salado Civic Center not later than 21 days before the election. The notice shall be substantially in the form of Notice of Election attached hereto as Exhibit "B" and made a part hereof for all purposes.
- 11. At the election each voter shall vote for five aldermen, cast one vote for mayor, and cast one vote for city marshall. The aldermen candidates receiving the five highest number of votes shall be elected aldermen, and the candidate receiving the highest number of votes for mayor shall be elected mayor. The candidate receiving the highest number of votes for city marshall shall be elected city marshall.

Each voter may vote for a candidate by placing an "x" in the square opposite the candidate's name.

- 12. That the official ballots for said election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote for the candidates or candidate of their choice by placing an "x" in the square opposite the candidate or candidates' name. The ballots to contain such provisions, markings, and language as required by law.
- 13. That in all respects, said election shall be conducted in accordance with the Texas Election Code.
- 14. It is hereby declared to be the intention of the Board of Aldermen of the Village of Salado that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph, or section

of this ordinance should be declared invalid by the final judgment or decree of a court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this ordinance. since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such invalid phrase, clause, sentence, paragraph, or section.
