 <u>Variance Request to the Zoning Ordinance from Property Owner at 425 Thomas Arnold Road to Cover Parking Lot with Gravel instead of Paving</u>. Johnny's Steaks and BBQ has asked to be allowed to place gravel on their parking lot instead of paving it as required by the zoning ordinance. There were concerns expressed by both citizens and board members about excessive dust if the variance is granted and excessive water runoff if variance is not granted. There was one written comment submitted by citizen Brian Dunlap opposing the variance. Chairman Russell called for a vote to grant the variance. Vote failed three to two with Hans

Fields and Shiela Lehmann opposing.

2. <u>Variance Request to the Zoning Ordinance from Property Owner at 775 Van Bibber to Allow a</u> <u>Core-In Rusted Metal Fencing with Steel Columns and Sandstone Masonry instead of Solid</u> Masonry or Wood Screening.

Billy Pipes has asked to place a core-in rusted metal fence with rock pillars around a portion of his newly developed subdivision, Tuscany on the Creek, instead of the wood or metal fencing as required by the zoning ordinance.

Chairman Russell called for a vote to grant the variance. Vote passed unanimously.
