Minutes of Special Meeting of Board of Aldermen
May 9, 2019 at 6:00 p.m.

The Board of Aldermen meeting was called to order at 6:03 p.m. by Mayor Skip Blancett.

Board Members Present: Mayor Skip Blancett, Mayor Pro-tem Frank Coachman, Aldermen Andy Jackson, Michael Coggin, and Michael McDougal (via videoconference).

Staff Present: Village Administrator Don Ferguson and City Secretary Cara McPartland

Election Matters

- A. Canvass returns of the Village of Salado General Election of May 4, 2019. (*Village Administrator*)

Village Administrator Ferguson presented canvass materials distributed to Board members. He presented the following results to the Board:

He stated that Aldermen-elect Amber Preston Dankert, John Cole, and Rodney W. Bell received the highest number of votes.

- B. Discuss and consider approval of an ordinance of the Village of Salado, Texas, declaring the canvass of the results of the May 4, 2019, General Election held for the purpose of electing three (3) aldermen of the Village of Salado Board of Aldermen and all matters related to holding such election; providing for findings of fact, providing for severability; repealing conflicting provisions; proper notice and open meeting, and providing an effective date. (*Village Administrator*)

Mayor Blancett introduced the item and entertained a motion.

Mayor Pro-tem Coachman moved to approve the ordinance declaring the canvass of the results of the May 4, 2019 General Election, as presented. Alderman Jackson seconded. Motion carried on a vote of 4-0.

- C. Complete and issue certificates of election to aldermen-elect. (*Mayor Skip Blancett*)

Village Administrator Ferguson advised that Aldermen-elect Amber Preston Dankert, John Cole, and Rodney W. Bell will be sworn in at the Board's regular meeting on May 16, 2019 at 6:30 p.m.

Mayor Blancett presented the certificates of election to Aldermen-elect John Cole and Rodney W. Bell. Alderman-elect Amber Preston Dankert was not present.

Aldermen-elect Cole and Bell thanked their supporters and expressed appreciation to the Board for their service and looked forward to serving. Mayor Blancett thanked Linda Reynolds for running a good race for office.

Village Administrator Ferguson reminded there will be a reception for outgoing Aldermen Andy Jackson and Michael McDougal from 6:00-6:30 p.m., immediately prior to the Board's regular meeting on May 16, 2019.

Adjournment


